Sahib Kanshi Ram devoted his life for the eradication of caste from the domestic structures of Indian socio-religious realm. Sahib Kanshi Ram Ji was an innovative thinker and a charismatic mass leader who coined new political vocabulary for the mobilization of downtrodden. The slogans he chiseled adroitly caught the imagination of all and sundry throughout the length and breadth of India. He told his people unless and until they formed their own social and political organizations, no upper caste political party will allow them to come to rule India. And he was confident that given the 85 percent strength of Bahujan, if the latter joined hands no one in the world can stop them reach Delhi. His untiring efforts and firm faith in his people brought success though in some parts of the country. But as far as awareness among the Bahujan is concerned his was a great success.

Human-Centric Globalisation: Taking G20 to the Last Mile, Leaving None Behind

'Vasudhaiva Kutumbakam' – these two words capture a deep philosophy. It means 'the world is one family'. This is an all-embracing outlook that encourages us to progress as one universal family, transcending borders, languages, and ideologies. During India's G20 Presidency, this has translated into a call for human-centric progress. As One Earth, we are coming together to nurture our planet. As One Family, we support each other in the pursuit of growth. And we move together towards a shared future - One Future - which is an undeniable truth in these interconnected times.

The post-pandemic world order is very different from the world before it. There are three important changes, among others.

First, there is a growing realisation that a shift away from a GDP-centric view of the world to a human-centric view is needed.

Second, the world is recognizing the importance of resilience and reliability in global supply chains.

Third, there is a collective call for boosting multilateralism through the reform of global institutions.

Our G20 Presidency has played the role of a catalyst in these shifts.

In December 2022, when we took over the Presidency from Indonesia, I had written that a mindset shift must be catalysed by the G20. This was especially needed in the context of mainstreaming the marginalized aspirations of developing countries, the Global South and Africa. The Voice of Global South Summit, which witnessed participation from 125 countries, was one of the foremost initiatives under our Presidency. It was an important exercise to gather inputs and ideas from the Global South. Further, our Presidency has not only seen the largest-ever participation from African countries but has also pushed for the inclusion of the African Union as a permanent member of the G20.

An interconnected world means our challenges across domains are interlinked. This is the mid-way year of the 2030 Agenda and many are noting with great concern that the progress on SDGs is off-track. The G20 2023 Action Plan on Accelerating Progress on SDGs will spearhead the future direction of the G20 towards implementing SDGs.

In India, living in harmony with nature has been a norm since ancient times and we have been contributing our share towards climate action even in modern times.

Many countries of the Global South are at various stages of development and climate action must be a complementary pursuit. Ambitions for climate action must be matched with actions on climate finance and transfer of technology.

We believe there is a need to move away from a purely restrictive attitude of what should not be done, to a more constructive attitude focusing on what can be done to fight climate change.

The Chennai HLPs for a Sustainable and Resilient Blue Economy focus on keeping our oceans healthy. A global ecosystem for clean and green hydrogen will emerge from our presidency, along with a Green Hydrogen Innovation Centre.

In 2015, we launched the International Solar Alliance. Now, through the Global Biofuels Alliance, we will support the world to enable energy transitions in tune with the benefits of a circular economy.

Democratising climate action is the best way to impart momentum to the movement. Just as individuals make daily decisions based on their long-term health, they can make lifestyle decisions based on the impact on the planet's long-term health. Just like Yoga became a global mass movement for wellness, we have also nudged the world with Lifestyles for Sustainable Environment (LiFE).

Due to the impact of climate change, ensuring food and nutritional security will be crucial. Millets, or Shree Anna, can help with this while also boosting climate-smart agriculture. In the International Year of Millets, we have taken millets to global palates. The Deccan High Level Principles on Food Security and Nutrition is also helpful in this direction.

Technology is transformative but it also needs to be made inclusive. In the past, the benefits of technological advancements

have not benefited all sections of society equally. India, over the last few years, has shown how technology can be leveraged to narrow inequalities, rather than widen them.

For instance, the billions across the world that remain unbanked, or lack digital identities, can be financially included through digital public infrastructure (DPI). The solutions we



have built using our DPI have now been recognised globally. Now, through the G20, we will help developing countries adapt, build, and scale DPI to unlock the power of inclusive growth.

That India is the fastest-growing large economy is no accident. Our simple, scalable and sustainable solutions have empowered the vulnerable and the marginalised to lead our development story. From space to sports, economy to entrepreneurship, Indian women have taken the lead in various sectors. They have shifted the narrative from the development of women to women-led development. Our G20 Presidency is working on bridging the gender digital divide, reducing labour force participation gaps and enabling a larger role for women in leadership and decision-making. For India, the G20 Presidency is not merely a high-level diplomatic endeavour. As the Mother of Democracy and a model of diversity, we opened the doors of this experience to the world.

Today, accomplishing things at scale is a quality that is associated with India. The G20 Presidency is no exception. It has become a people-driven movement. Over 200 meetings will have been organised in 60 Indian cities across the length and breadth of our nation, hosting nearly 100,000 delegates from 125 countries by the end of our term. Mischievous Suggestions to Change the Constitution of India – Constitution of India is a living document and as such remains in the news on one count on the other. India is passing through challenging times in its 'tryst with destiny' under various cross currents. There had been fears and concerns floating around about change of the constitution by vested interests in the ruling outfits and right-wing Hindutava elements; particularly ever since the BJP government came into power in 2014. Assembly debates. India's Constitution today isn't what we inherited in 1950 and rightly so." Recently speaking in the Rajya Sabha, Former CJI Ranjan Gogoi also expressed his doubts on the so called 'basic structure of the constitution'. People think that these utterings are deliberately and purposely made to 'test the waters' by the 'Hindutava' forces who intend to change or even abrogate the constitution. Let us wait and see. But there are many questions which need to be answered in this regard – Though it was clarified that these were the personal views of Bibek Debroy yet it would need to be clearly stated by the Government of India, BJP,

Ambedkar Power – Growing Relevance – It may seem somewhat strange and even bizarre to coin a word like 'Ambedkar Affect'. It may also be called a far-fetched preposition – Ambedkar Power is getting increasingly visible in the polity and socio-economic structures of the country and with this relevance of dalits or the weaker sections is getting new meanings. I don't know whether I would succeed in making my point but nevertheless,

I would try and say it anyway. One may recall in 1946 when the first interim government was formed, Congress Party and Muslim League were given equal number of Ministerial berths in the Council of Ministers. Dalit identity by then was already established. Congress Party nominated Jagjivan Ram to give representation to dalits (Ambedkar was not in the reckoning as he was a staunch opponent and critic of Congress Party) and to match the Congress Party, Muslim League nominated Joginder Nath Mandal to accommodate dalit interests. This

drama of owning or appropriating dalits started well before the independence. And it continues till today in one way or the other both by the Congress Party and the newly emerged the other biggest party, BJP. Ambedkar and his legacy, to my mind, are solely responsible to bring about this visible scenario with regard to dalits or Scheduled Castes to come in the national reckoning.

It seems that it, the Ambedkar Affect, would remain so in the years to come. Congress Party appropriated Babasaheb Ambedkar by nominating him to the Constituent Assembly, making him the Chairman of the Drafting Committee to write the Constitution, appointing him the first Law Minister of India (Pakistan did the same to Joginder Nath Mandal but later things changed and it is a separate issue).

Congress Party promoted Jagjivan Ram and the likes of D. Sanjivayya to counter Babasaheb Ambedkar and later the likes of Buta Singh, Chand Ram, Yogendra Makwana etc. came to the centre stage and roped in B.D. Khobragade, B.P. Maurya, Ram Dhan among others to give representation to SCs in the power structures of the country. BJP in the run up to become a pan-India political force in the 1970s, started looking



for SC faces to attract the SC vote banks and brought to their fold educated SCs like Ram Nath Kovind, Suraj Bhan, Sonkar Shastri, Sanjay Paswan among others. Congress Party made K.R. Narayanan first Vice President and then President of India to

please the SC communities as a well thought-over strategy. 'Ambedkar Affect' was at work in shaping the political landscape for the SCs in the scheme of things of both Congress Party and BJP. BJP made Ram Nath Kovind the President of India, recognized Ambedkar by making memorials and celebrating Ambedkar's 125th birth anniversary, appointed a couple of Governors, made Droupadi Murmu, the President of India. BJP is fully aware of the Ambedkar Affect in the electoral aspects to remain in the corridors of power not only in Delhi but also in the state capitals. In turn, Congress Party picked up Mallikarjun

Kharge as the President of Congress Party. Though Kharge Sahib is a leader by his own right yet Ambedkar Affect also played its role in his alleviation to the coveted position.

To cut the story short, I come straight to the new political phenomena coming into play in tactical and strategic political moves of BJP to counter Ambedkar Affect and to amend the Constitution of India, linked with the persona of Ambedkar and his legacy, to promote their subtle agenda of Hindutava by firing the salvos from the shoulders of SC leaders in the BJP – appointed Arjun Meghwal as the Law Minister to oversee and pilot the controversial legislative framework at this crucial and challenging times and more recently appointed Former President of India, Ram Nath Kovind as Chairman of the Committee to study and make a report on the issue of 'One Nation – One Election'. I don't know exactly whether in the past any government made a Former Mahamahim to Chair a government committee to carry forward its political agenda. Anyway it is a separate matter.

The crux of the matter is 'Ambedkar Affect' - Ambedkar Ka Zaddu Sar Chad kar Bol Raha Hai. Ambedkar Power is a potent power and will remain so in the days to come. Sac County Jail Dilemma - Choices are Limited

My position on criminal justice has always been clear: we must protect citizens from criminal predators, support the men and women who keep us safe, hold individuals accountable, and reduce the number of victims in the future. Every decision I make reflects these principles.

The County jails play an important role in helping our Sheriff Deputies and Law Enforcement keep our neighborhoods and businesses safe. However, recent lawsuits and state mandates have pressed the County to upgrade our jails. If we don't, we face the threat of federal receivership where they make the decisions, and we assume the cost.

The lawsuit (Mays Consent Decree) requires enhanced accessibility, services, and safety in our jails. The County is required to bring our jails into compliance with ADA and HIPAA, provide proper out of cell time, improve the conditions in our jails with medical and mental health facilities that are appropriate for inmates in need and improve our intake facilities.

Both the main jail and the Rio Consumnes Correctional Center (RCCC) were built before regulations like the Americans with Disabilities Act (ADA) of 1990 and the Health Insurance Portability and Accountability Act (HIPAA) of 1996. Without action by the Board, we risk Federal oversight and unchecked spending on taxpayer money.

On August 8, the County board reviewed and approved our response to the Grand Jury report from June 2, 2023, titled "What's Taking So Long?" It is important to note that the Grand Jury's mandate is to ensure transparency and accountability. They initiate investigations in response to resident or elected official's concerns. The investigations result in a public report, which requires a public response directed to the Superior Court's Presiding Judge as laid out in Penal Code Sections 933 and 933.05.

Our Board has also received criticism from citizens who seek to decrease jail populations and who express concern that capital improvements will equal expansion of the jail's inmate capacity.

The Grand Jury report correctly identified AB109 as a driving force behind which inmates are in our jails, and it is surprising to note that the daily average inmate count is currently lower than it was in 2011 when AB109, the California Public Safety Realignment Act of 2011 was imposed by the Legislature.

AB109 enacted early releases for some criminals and shifted others to be housed in our county jails. The jails that normally housed inmates for 1 to 2 years are now housing some inmates for up to 13 years. This change increases the costs for taxpayers.

Additionally, Props 47 and 57 created a new challenge: either release criminals or create alternatives to monitor them outside of a jail setting. Our

County chose the latter. The alternative strategies, created with the input and backing of both the Sheriff's Department and the District Attorney's Office, are designed to keep our community safe and ensure criminals are still held accountable.

The legislature has redefined the way we look at crime. What used to be a felony is now a misdemeanor. We are now subjected to laws that allow a person to steal up to \$1,000 and it is a simple misdemeanor. At the same time, legislation like SB 553 make it illegal for retail owners to ask employees to protect their business. This bill sends an inviting message to criminals and makes our businesses more vulnerable.

I support improving conditions in our jails for all: inmates, officers, and staff. Some have shared with me how jail intervention changed their lives, helping them overcome drug addiction. I know victims who are comforted, knowing their attacker is serving time behind bars. Jails are necessary for our society, and we are making progress towards the Mays Consent Decree compliance. Plans are moving forward for a facility focusing on medical, mental health and intake services. The Board will receive the final design concepts and budget soon.

Final Recommended Budget Hearings Begin Sept. 6

The Sacramento County Board of Supervisors will begin Fiscal Year (FY)



2023-24 Revised Recommended Budget hearings on Wednesday, Sept. 6, at 9:30 a.m. in Board Chambers in the Sacramento County Administration Building, located at 700 H Street, Sacramento, 95814. If necessary, hearings will continue on Sept. 7 and 8 at the same time and location.

Board Deliberation and Approval to Revisions of the Approved Recommended Budget

The numbers in the recommended budget change between June and September when the County receives new information, including the impact of the State Budget and updated revenue totals. Because of that

new information, the Revised Recommended Budget comes back to the Board for review and adoption in September.

The Board of Supervisors approved the FY 2023-24 Recommended Budget on June 7. The \$8.4 billion spending plan recognized new and enhanced areas of growth based on the Board's priorities and a survey of Sacramento residents. The budget included annual commitments of \$35 million to fund new or enhanced programs aligned with the County's jail population reduction plans to comply with the Mays Consent Decree; \$10 million in the Sheriff and Correctional Health budgets to fund continued efforts for additional staffing and services in the Mays Consent Decree Remedial Plan; \$12 million to fund new programs and services addressing homelessness; \$84 million of growth in Health Services; \$17 million in additional funding for Child, Family and Adult Services; and \$5 million to address road repairs and improvements in the unincorporated County, among others.

Members of the public may attend the hearings and be heard on any item in the budget, either publicly, over the phone or through written comments. The budget hearings will also be telecast live on Metro Cable 14 and on the web.

Florin Road Safe Stay Welcomes Guests

On Monday, August 21, 2023, Sacramento County's first Safe Stay Com-



munity welcomed its first guests. The sleeping cabin-style shelter campus has a capacity of 125 – 75 single cabins and 25 double occupancy cabins and was approved by the Board of Supervisors in June 2022. The first two guests are a couple that will use one of the double occupancy cabins.

What Can Guests Expect?

On-premise guests can use the bathroom and shower trailers, laundry services and eat three meals a day in the common area. The campus also has a gated pet relief area, a computer lab, an entertainment space, employment development and housing-focused case management. Guests will also be connected with transportation resources for off-site needs such as medical appointments or jobs.

Each cabin is outfitted with a bed that folds down from the wall, two storage containers, basic toiletry

supplies, a desk and chair, overhead light, HVAC, power outlets, smoke alarm and fire extinguisher and a locking door. Cabins also have enough space to accommodate a dog bed or pet crate. The campus has storage containers for possessions that do not fit in the sleeping cabins.

The Florin Road Safe Stay community is operated by City Net. City Net has more than 25 employees dedicated to managing the campus, as well as meeting client's basic needs. Employees also provide case management and housing navigation.

How Are Guests Referred?

The Florin Road Safe Stay Community is currently a closed referral process, through homeless services providers engaging with people living outside near the shelter. Existing street outreach providers, both within the City of Sacramento and in the unincorporated area of Sacramento County, will engage with people living outside

to evaluate what services and shelter programs they are eligible for and that will best meet their needs.

People experiencing homelessness and looking for shelter resources should contact the Housing Crisis Line by calling 2-1-1 and pressing 8 or the toll-free number at 1-844-546-1464.


